Re: Change – Freshmen “expected” to bring their own laptops

Dear Parents,

The world has shifted once again. As your student enters 9<sup>th</sup> grade next year, they will be exposed to a variety of new learning opportunities. Teachers at Glencoe-Silver Lake High School have been working to incorporate the 21<sup>st</sup>-century skills of collaboration, communication, critical thinking, problem solving, creativity and innovation into their curriculum. We at Glencoe-Silver Lake Public Schools feel that equal access to technology is an important factor in preparing our students for their future endeavors. We may not be able to envision the types of jobs that will be available to our students as new technologies emerge, but we can identify the skills that are needed and integrate them into classes to help our students be successful.

We want our students to be a part of a safe and welcoming environment where they will be well equipped to pursue future career paths with confidence. Technology plays a key role in this. It is our goal to provide a safe place to teach students about the benefits of technology and how to be responsible and ethical learners in the digital age. Teachers will help students practice appropriate and professional behavior while actively participating in authentic learning experiences. These experiences will help prepare them for the inevitable use of technology they will encounter regardless of the path they choose in life.

For the 2017-18 school year, students in 9<sup>th</sup> grade will be asked to have a Chromebook or similar electronic device for use in the classroom.

In brief, we are recommending three choices in regards to laptops for High School students:

1. Parents may supply a laptop. There are minimum requirements for these machines, which are delineated below.
    - a. Operating system
      - i. Windows 7, or Higher (with current anti-virus installed)
    - b. Hardware
      - i. An Intel Core 2 or equivalent AMD/Celeron Processor and at least one gig Ram
  2. Parents may choose to purchase a laptop. The District has selected four options in regards to this choice. Minimum required, Middle of the road, and higher end options. If you have questions, by all means, send those questions to Mr. Jenson, Director of Technology, Glencoe-Silver Lake Public Schools.

3. The district will supply a device for students who do not have one.

Just to be clear, the school district is not requiring high school students to bring or purchase their own computer. The district will still supply a device when necessary. A district-supplied device may not be new, cannot be taken home, and can only be accessed during class time or ECL. The device being used will be a shared device accessed by other students throughout the day.

As I stated at the start of this letter, the world has shifted once again. A laptop has become as fundamental to education as pencils, notebooks, and textbooks used to be.
